DEAN PAATSCH - STATEMENT - HOCKEY FEASIBILITY STUDY

My name is Dean Paatsch and on behalf of the Brunswick Hockey Club committee I want to express our gratitude, firstly on the excellent feasibility study that Council has funded and enabled, and for the support of the Councillors and officers over the last two years we have been engaged with in this process.

The study makes it clear there is ample demand for a second Hockey Pitch in Moreland, post COVID when most community sports clubs declined, we grew.

Our 475 players are the equivalent of 21 AFL teams, 31 Soccer teams and 43 Cricket teams. We have grown 10 per cent each year for the last five years and that will continue. Why? What lies behind our success are our values. Five years ago we set up the Wickers Academy, we chose 15 under 15 year olds who we taught to umpire, coach and give back to the community. Those kids run a six week after school program in public housing estates, they deliver Hockey clinics for 1500 kids in Moreland schools, they deliver a program for international students, all for free. They are the lifeblood of our club, some of them are here tonight, they model the behaviours parents want to see in community sport. For us participation and inclusion come first.

Our pitch has no shade, no seating, no tech bench, no pavilion at the ground. The carpark is always full, some nights 4 teams train on the ground at the same time. There are no showers, no hot water and not enough change rooms but what we lack in infrastructure we make up in spirit.

Success to us isn't winning, it's giving a reason for a COVID depressed teenager to get off the couch, it's creating a space for our queer and multicultural players to bring their whole selves to play. It's the friendships amongst our veterans who have played together for 30 years or seeing or young people flourish when they give back to others.

So, don't build us a gilded cage, we don't want one. This club is modest, of the \$10 million to \$14 million the study earmarked for construction, less than \$2 million was dedicated to the pitch. We want a pitch, a pitch that we can make available on McDonald Reserve that can be available to the people of Coburg High, the most underfunded school in this community.

Hockey is only played on synthetic surfaces, Hockey Australia has already done the work to minimise the environmental impact, we don't want to be caught up in party politics or soccer politics or extremist politics on this issue. If we can build a road safely we can build a Hockey pitch safely.

As you vote tonight, lets keep the project rolling. Put a new pitch first in a phased approach and give us a chance to keep our community contribution flowing.

JOHN ENGLART - QUESTION - HOCKEY FEASIBILITY STUDY

My daughter played junior hockey for a couple of years. So, while I welcome this feasibility study I think there are a number of issues with the consultant's report.

1. Great effort has gone into highlighting the social need and benefits of a new field hockey pitch in our municipality, and I acknowledge that.
2. While the environmental impacts and impacts to other sports and active recreation are mentioned, there is little detail given commensurate with the argument put forward for hockey.
3. There is one environmental impact which is totally missing from this report: microplastics Pollution. Is this an issue? Ask Port Philip Bay Keeper Neil Blake OAM about synthetic fibres pollution with KP Hardiman Reserve in Darebin, used for hockey. Or refer to Martin Sheppard of Smart Connection Consultancy who wrote the Sports Surface Needs Analysis for Council in 2018 who prepared an assessment in 2021 of ways to mitigate some of the damage of microplastic pollution.

My last point I'd like to raise is siting. One of the sites, Parker Reserve in North Coburg, is partly built on a waste tip with evidence of some subsidence. This may require extra stabilisation work for the base of a hockey pitch to be built. Secondly, a synthetic hockey pitch being built next to Merri Creek any microplastic pollution finding its way into the creek environment will impact aquatic ecosystems and the food web and contributing to plastics pollution in Port Philip Bay.

DANIEL FRIEDMAN - QUESTION - HOCKEY FEASIBILITY STUDY

Will the Councillors at Moreland City Council recognise the North Coburg Rebels Baseball club as a legitimate, diverse, vibrant and blossoming sporting entity in the their electorate and protect the club and its future?

Mayor, Cr Mark Riley responded:

No decisions will be made in regards to this matter in the agenda tonight, it is a feasibility study. We will be looking for feedback and engaging with people regarding the spaces we are looking at.

DR SEAN MULCAHY - STATEMENT - SUPPORTING TRANS AND GENDER DIVERSE PEOPLE

My name is Dr Sean Mulcahy, and I am a campaigner with the Victorian Pride Lobby's Rainbow Local Government campaign.

We all agree that everyone deserves to be treated with dignity and respect.

Just like all of us, trans and gender diverse people are active and engaged members of our local community, including in community sport.

And just like all of us, trans and gender diverse people need safe and inclusive spaces where our value and contribution to society is recognised and celebrated.

In recent years we have seen significant gains in the rights of lesbian, gay, bisexual and transgender Australians, but that hasn't come without opposition and now those opposed are seeking to weaponise trans people's rights and identities to push their own regressive political agendas.

This has been particularly concentrated within far-right extremist movements who seek to demean trans and gender diverse people for their own political gain.

During the 2022 federal election, we could all see how this issue was weaponised by extremist politicians in a bid to gain media attention, but we know the vast majority of people in Australia and in Moreland support trans and gender diverse people.

This motion asks Council to do three things:

- issue a public statement of support for the inclusion of trans and gender diverse people in all sports in Moreland/Merri-bek;
- review Council policies regarding trans and gender diverse inclusion, anti-discrimination, and diversity; and
- consider the development of an LGBTIQ+ Action Plan to progress this further.

Over 10,000 people participate in organised sporting competitions in Moreland.

There are six pools or leisure centres in the municipality, and a huge number of sporting clubs, sports grounds and facilities.

Council has an important role to play in fostering inclusion in sport.

Please support this motion for trans inclusion.

AVA BALDWIN - STATEMENT - SUPPORTING TRANS AND GENDER DIVERSE PEOPLE

My name is Ava. I've lived and worked in the Merri-bek area in Brunswick East right off of Lygon Street for nearly 4 years now and I've loved every day of it.

The people are unconditionally friendly and vibrant. I've spent countless mornings wandering the beautiful Merri Creek. I love food too so being able to try all kinds of cuisine within walking distance is such an amazing privilege. But as a transgender woman, the exclusionary and transphobic language that has targeted trans and gender diverse people as of late, has been painful.

Each new restriction on participation in a sport, each misinformed statement about my body as a trans person, erodes my own self image and makes it hard to maintain a positive outlook on the future. When these statements come from political representatives, and major sporting regulators I feel isolated. Alienated. Things I should not feel when I simply want to live truthfully, as myself.

This motion will help trans and gender diverse people in the Merri-bek community feel welcomed, in sport and the wider community. A public statement against all forms of transphobia and trans-misogyny will set a clear precedent that everybody living here deserves respect and dignity. Proactive anti-discrimination, and diversity and inclusion policies will ensure fair representation and opportunity.

I strongly urge each of you to support all points of this motion, to support each of us, and our place in this community.

RACHEL LAMARCHE - QUESTION - EPPING ANIMAL WELFARE FACILITY

Can Moreland Council guarantee the change in management won't increase the number of companion animals being killed at the Epping Animal Welfare Facility, including animals currently in the facility?

At the request of the Mayor, Anita Curnow, Director City Infrastructure responded:

The Council in-house model will deliver an improved level of service, meeting all compliance requirements. The standard and quality of care for animals will ensure compliance with relevant codes and will be managed and resourced by experts in animal care and welfare.

The facility will still be providing stray, abandoned and surrendered animals with refuge and a new life. Promoting pet wellbeing, reuniting pets with their owners, finding new homes for not owned cats and dogs and providing education regarding responsible pet

ownership are our priorities. The facility will only euthanise animals as a very last resort when this is the most humane option.

RSPCA Victoria has advised the partner councils that they will remove animals who are past the eight day statutory hold period to their other shelters after 16 October. Any animals still within the eight days will remain at the Facility and be cared for by Whittlesea Council.

TANYA KONONOV ON BEHALF AISLING WOOD - STATEMENT - EPPING ANIMAL WELFARE FACILITY

I represent Forever Friends Animal Rescue, one of the largest animal rescue organisations in Victoria.

I would like to reiterate that it is unethical and unsustainable to outsource such an essential council service as animal rehoming to unpaid community members. We do not have the capacity to provide this service, we were not consulted on this proposed change and we do not consent to it.

Whilst Forever Friends was invited by Whittlesea Council to sign an agreement giving us the option to take animals from Epping for rehoming, we were never advised that the shelter would be ceasing to offer adoptions to the public. Almost all animal rescuers are unpaid volunteers, and close to 100% of us are women, many with responsibility for caring for children and/or elderly parents. Most of us also do full-time paid work to support ourselves and our families. Whittlesea is not offering any funds to rescuers – either for essential veterinary care, or for our labour. And yet, the only way for unclaimed and surrendered animals to make it out of the pound alive is via rescue groups.

My question is, does council think it is acceptable to offload responsibility for rehoming more than 2000 animals a year to unpaid community members?

At the request of the Mayor, Anita Curnow, Director City Infrastructure responded:

The City of Whittlesea advises that formal agreements have been entered into with more than 20 rescue groups, including some major animal welfare partners. Animals will be made available to all rescue groups that have entered into a section 84Y Agreement with the City of Whittlesea. We understand that there may be times when the rescue groups do not have capacity to take on animals. In this instance the animals will remain at and be adopted out of the facility.

KATHLEEN CHAPMAN - STATEMENT - EPPING ANIMAL WELFARE FACILITY

My name is Kathleen Chapman, and I am one of the organisers of the community movement calling for animal adoptions to continue at Epping Animal Welfare Facility.

Moreland is one of the most progressive communities in Australia. Residents care very deeply about animals. Moreland deserves – and its residents demand - an animal shelter where animals' lives are valued.

Animal adoptions are an essential service that should be provided by paid, professional staff. It is not ethical and not sustainable to offload 100% of the responsibility for animal adoptions to unpaid community members, who also need to do paid work in order to support themselves. I'm a Darebin resident, and about 10 years ago, I discovered that the council pound contractor was killing more than 90% of cat. I lobbied Darebin council to make unclaimed and surrendered animals available to rescue groups if the pound provided did not intend to rehome them.

My motivation was to save animals' lives, the same reason I am standing here today. Darebin Council did introduce a requirement that its pound contractor make surrendered and unclaimed animals available to rescue groups. I contacted a large number of rescue

groups to take animals from Darebin, however, while there were more than 20 groups on Darebin's contact list, in reality, at any one time, there were usually only 2-3 groups regularly taking cats. These groups did not have enough foster carers, so I took on responsibility for finding carers for most of the cats. In addition, the groups did not have enough volunteers to coordinate tasks such as organising veterinary care and promoting animals for adoption, so I took on that role as well. It was a huge responsibility and resulted in an incredible amount of stress. Whether animals lived or died depended on whether I could find enough foster carers, and find the time to arrange their release from the pound, book their vet work, arrange transport and sometimes even fundraise to pay for veterinary care. This was like a full-time job, on top of my paid full-time job. I made calls on the train on my way to and from work, stayed up late every night working on administrative tasks, spent every weekend and all my annual leaving working on rescue. I was spoken to by my supervisor for taking rescue calls during work hours. I was stressed and exhausted, but I knew I had to keep going, or animals would die.

The solution to low rehoming rates and high kill rates in pounds is to focus on expanding and improving adoption programs, not offloading this responsibility onto unpaid community members, who don't have the capacity to do this on an ongoing basis.

PETER KYRIOPOULOS - QUESTION - MASTERPLAN FOR DUNSTAN RESERVE

My name is Peter Kyriopoulos, I am the president at Brunswick City SC, a community club with around 400 players in the National Premier League, State league, Community league, MiniRoos competition and our social programs for women, girls and gender-diverse people from Moreland and beyond. We have enjoyed support from Moreland Council Sport and Recreation teams over the years and as a committee, we have recently had supportive conversations with Cr Angelica Panopoulos, Cr James Conlan, Cr Helen Davidson and Cr Oscar Yildiz.

I think it is important to share the concerns that our members have clearly expressed to us with you.

In our last member consultation, 75% of responses indicated strong dissatisfaction with the quality of the grounds at Dunstan Reserve. We have had 200+ training sessions cancelled this season alone due to the poor ground conditions. The capital investment from Moreland / Merri-bek Council to date hasn't gone far enough, so we invite the Moreland / Merri-bek Council to work with the Brunswick City SC community on immediate and longer-term solutions.

I am happy to provide additional information after this meeting if needed.

We ask for the Moreland / Merri-bek Council to consider the following 5 initiatives that will ensure both immediate and longer-term positive outcomes on the safety, accessibility and sustainability of our community sport.

1. Making CB Smith Reserve main pitch available to Brunswick City SC for 1.5 hours starting next season. This will reduce the burden on Dunstan Reserve and allow us to schedule more Senior Women's matches on the North pitch so they're treated equally.
2. Allocating long-term funding to upgrade Dunstan Reserve. Future funding must be equitable: while AFL clubs are allocated \$23.5 million in capital expenditure over 5-10 years to update grandstands and grounds (compared to \$7.4m for soccer), Brunswick City lacks a safe playing field.

3. Consult with the community to find solutions for all users of Dunstan Reserve. The reserve is both a dog park and a soccer ground, this leads to avoidable player injuries, we need to find solutions that work for everyone.
4. Installing gates at the North Pitch so access can be reasonably restricted to maintain the 15 hours use per week prescribed by the council to protect the surface.
5. Moreland Council must commit to the development of a Master Plan for Brunswick City SC. We welcome the commitment by council to research the best practice in natural turf and express our interest in participating in the implementation of the findings.

How will the Moreland/Merri-bek Council work with Brunswick City SC Committee to develop a Master Plan and address our immediate needs as outlined in my statement? At the request of the Mayor, Eamonn Fennessy, Director Community responded:

Peter, thank you for coming tonight and thank you for the work that you and Brunswick City SC do for Soccer and our city.

Soccer is huge in Moreland and a very important part of our fabric. With that growth and participation comes an increasing need to plan and resource infrastructure pressures on allocations, which you have outlined very well. We are experiencing that across a lot clubs. The recreation team and I would like to come out and talk through these issues with you, and work out the pathway for how to deal with them best

In terms of broader planning for Dunstan Reserve we have a review of the Moreland open space strategy coming up this year, which is our overarching open space strategy for the city. It looks at the use and development of open space for a whole range of values.

Questions and Statements taken on notice

MARY BORG - QUESTION – PLANNING SCHEME AMENDMENT C208MORE

Council report acknowledges numerous submitters are concerned about financial burden to maintain Heritage Overlay. Yet panel has said looking into grants and funding from Victorian Heritage Restoration Fund or any where else, is outside this scope. This needs to be included in scope to ensure heritage is maintained and landowners can pay for these repairs and upkeep. How are the broader economic benefits going to help land owners pay for this upkeep? It is hard to find trades skilled to maintain these examples.

Landowners need clearer details on what can and cannot be changed? In regard to terraces, Dr James mentions a sympathetic style/ form? What does this mean? Access to these properties is already very restrictive. Heritage Overlay will add more limitation.

The Mayor took these questions on notice.

WARRAN HOCKING - STATEMENT - HOCKEY FEASIBILITY STUDY

I am a resident of Coburg North and am an active user of open space in our area. I also support more opportunities for active and passive activities.

I don't believe Parker Reserve is a suitable option, as the stadium will take up majority of the available open space used by walkers, dog owners, joggers, informal cricket games and many more activities.

With this area gone Coburg north and Merlynston will have very little public open space for personal health and wellbeing with Hosken Reserve being turned into an NPL hub and now the only other available space turned into a synthetic hockey hub. The Environmental impact needs to be also considered, such venues should be considered for industrial

areas that are unused and not taking away natural open space which Moreland ranks among the lowest of all municipalities.

Open space we do have is widely used by all types of residents and provides for a healthier and active community. Similar to synthetic soccer fields it is detrimental pigeon holing spaces to one sport and alienating local residents from access to natural open space. Please reconsider locations

AGGIE KASTANOS - STATEMENT - HOCKEY FEASIBILITY STUDY

My name is Aggie and I want to tell the Council about safety issues at the Dunstan Reserve soccer pitches in Brunswick West and the impact this has had on my family.

There are potholes, expanses of mud, and even puddles on the soccer pitches. Both of my children play for Brunswick City, and have been badly injured as a result of the council failing to maintain these surfaces.

Tea is my 18 year old daughter, she is passionate about soccer and has been playing since 10 years old. She began pre-season training last November. In just her second session she went for a shot at goal and fell in a pothole on the Dunstan south pitch. Her knee popped and we immediately knew she had torn her ACL. Téa was devastated.

We struggled to manage her emotions for a long time as she imagined the consequences this would have for her year ahead. She had surgery in March this year. But there were other effects too. She missed about a month of University, delayed her 18th birthday, lost her job etc . For three months it was too dangerous for her to do her job as a swimming instructor. She ended up quitting. That was a job she had done for years and she loved it. It also had a financial impact on our family. So far the surgery and physio has cost more than seven thousand dollars.

Tea had just got her licence when she did the surgery and couldn't drive. She would look at her car in our garage and would cry. At 18 years old, she should be having the best time of her life, but she was stuck at home with an injury, unable to attend uni, unable to work and unable to socialise. At the moment it looks like Téa won't be able to play the game she loves for a year.

My 14 year old son Teli was selected for Football Victoria's talent identification program. This was a big deal - it's what kids dream of. But six weeks ago he was playing a game on the Dustan Reserve north pitch when he fell in a pothole and tore the ligaments in his leg. Teli was really devastated. He only managed one session with the talent program and hasn't been able to finish his soccer season.

I have two kids who can't exercise. They can't play the sport they love. They are cut off from their friends and the community at the Brunswick City Soccer Club. I am a practicing psychologist. Kids who can't exercise experience depression and anxiety - and that affects every aspect of their lives - their education, their work, and their families. These kinds of injuries prevent a healthy balance in their lives.

My story is only one of many - there are dozens of players who have been injured because the Dunstan Reserve pitches are unsafe. My family has borne the very real impact of the council's negligence.

I am pleading with you to fix both pitches as part of a commitment to develop a Master Plan for Dunstan Reserve. These injuries are avoidable. It has never been more urgent.

Why would Moreland City Council's Chief Executive Officer (CEO), allow a Labor-aligned mayor to facilitate item 7.10 passing through Council with virtually no due diligence and/or public scrutiny?

The Residential Development Plans for C201MORE site were received from the site owner December 2019. Amendment C201MORE has potential to increase the Merlynston population by 25-30% (given an approximate Merlynston population of 3000 residents) yet the Hosken Reserve Masterplan documents consistently refer to expected low population growth. Why was the residential development C201MORE kept from residents throughout the Masterplanning Process?

7.1 AMENDMENT C208MORE - IMPLEMENTATION OF THE HERITAGE NOMINATIONS STUDY - GATEWAY 3 - CONSIDERATION OF PANEL'S RECOMMENDATIONS AND DECISION ON THE AMENDMENT

Executive Summary

Amendment C208more (the Amendment) seeks to implement the recommendations of the *Moreland Heritage Nominations Study* and complete the implementation of the *Moreland Heritage Gap Study*, to:

- Apply the Heritage Overlay to 45 individual heritage places, 1 serial listing, 7 new precincts and 3 precinct extensions
- Update the heritage value of 4 heritage places and 2 heritage precincts
- Fix mapping irregularities and heritage overlay boundaries
- Delete existing overlays from properties within the new serial listing
- Add the Moreland Heritage Nominations Study 2020 and a statement of significance for each place and precinct as a reference document

Council adopted the *Moreland Heritage Nomination Study* and resolved to commence the preparation of a planning scheme amendment to apply the HO to these properties at its meeting in August 2020 (DCF35/20). The Amendment was exhibited to the public for a period of 7 weeks and 43 submissions were received. Council resolved in December 2021 to request the Minister for Planning to appoint an independent Panel to consider the submissions received during exhibition of the Amendment.

A Panel Hearing was held on 1-3 March and 3 & 6 May 2022. The Panel report was generally supportive, noting that the Amendment was well founded and strategically justified. The Panel recommends that the Amendment be adopted subject to changes, generally related to updating information in the heritage citations and to remove seven places and two precincts from the Amendment.

Officers support the majority of Panel's recommendations but recommend that the Walsh Street Precinct (HO599) remains in the Amendment.

7.9 HOCKEY FEASIBILITY STUDY

Executive Summary

In 2021, the Brunswick Hockey Club approached Council seeking support for the construction of a second synthetic hockey pitch. Council resolved in June 2021 to commission a feasibility report to investigate and identify a suitable location.

The report has now been received and is at **Attachment 1**.

The feasibility report recommends Parker Reserve in Coburg North and MacDonald Reserve as the preferred sites for further investigation. Costings in the report suggest \$8 million - \$12 million (depending on scope) for Parker Reserve, and \$10 million - \$14 million for MacDonald Reserve (depending on scope). This significant scale project is not currently funded in Council's forward capital works program and other projects would need to be deprioritised in order to fund it. Council continues to face significant financial pressure on its capital works program.

The costings in the feasibility report require further analysis and more detailed costings will be required to further inform the possibility of a second hockey field in Moreland.

The study also further highlighted the need for more detailed site planning particularly in relation to ensuring a greater analysis of the triple bottom line - environmental, social and economic - assessment of not only the playing field surfaces options but the social benefits of this project.

In addition, since this study was commissioned, Council resolved in August 2022 to request a report and development of a policy on managing sports fields and open spaces surfaces. a report to consider a policy regarding sports playing surfaces across Moreland. This report will consider Council's current demand for, use and management of all sports surfaces – natural and synthetic - with consideration of Council's stance on the Climate Emergency, Integrated Water Management, Urban Heat Island Effect and zero waste by 2030 goals.

This officer report recommends deferring decisions on the outcomes of the Hockey Feasibility Study until the second half of 2023. Between now and then, funding options can be investigated, the capital works program will be reviewed as part of the annual budget process, and the report on sports playing surfaces will be completed.

7.3 DECLARATION OF THE CENTRAL COBURG SHOPPING PRECINCT SPECIAL CHARGE SCHEME 2022-2027

Executive Summary

At its meeting held on 11 May 2022, Council resolved to commence the statutory process to reintroduce a Special Charge Scheme (the Scheme) for the Central Coburg Shopping Precinct (Precinct).

The purpose of the Scheme is to defray expenses in relation to the performance of a function of the Council, if Council considers that the performance of the function will be of benefit to the persons required to pay the special charge. The funds are then provided to the Central Coburg Business Association Inc (CCBA) to be used for promotional, advertising, marketing and business development expenses associated with the encouragement of commerce, retail, hospitality and professional sectors activity and employment in the Precinct.

If declared, the Scheme will remain in force for the period commencing on 1 October 2022 and ending on 30 June 2027 (being a period of 4 years and 9 months).

The land and the properties in relation to which the Scheme is to be declared is the land and properties shown in the Precinct boundary map at Attachment 1 and remains unchanged from the most recent Scheme, which ended on 30 June 2022.

For the period of the Scheme, a total of \$1,020,320.03, will be levied by Council.

Following a Hearing of Submissions Committee meeting held on 1 August 2022, the Committee referred all submissions, objections and letters of support to be considered at the ordinary meeting of Council to be held on 14 September 2022.

The purpose of this report is for Council to consider the submissions and objections received by Council as a result of the statutory consultation process and to make a decision on the declaration of the Central Coburg Shopping Precinct Special Charge Scheme.

Officer Recommendation

Council resolve that:

1. Having considered all submissions received and taken account of all objections and complied with the requirements of sections 163A, 163B and 223 of the *Local Government Act 1989 (Act)*, and otherwise according to law, Council declares a Special Charge (Special Charge or Scheme) under section 163(1) of the Act for the purposes of defraying expenses to be incurred by Council in (administratively only) providing funds to the incorporated body known and operating as the Central Coburg Business Association (CCBA) which funds, subject always to the approval, direction and control of Council, are to be used for the purposes of promotional, advertising, marketing, business development and other incidental expenses as approved by Council and agreed to from time to time between Council and CCBA, all of which are associated with the encouragement of commerce, retail, hospitality and professional activity, and employment in the Coburg Shopping Precinct.
2. The criteria which form the basis of the declaration of the Special Charge are the ownership or occupation (and the capital improved value (CIV)) of the rateable land within the Scheme area which is used, or reasonably capable of being used, for commercial, retail or professional purposes, together with their respective tiered benefit classifications as otherwise set out in this declaration. The land included in the Scheme is situated within the geographical area in which the properties described in paragraphs 6 and 7 of this declaration are included.
3. In declaring the Scheme, Council is performing functions and exercising powers in relation to the peace, order and good government of the municipal district of the Moreland City, in particular the encouragement of commerce, retail, hospitality and professional activity, and employment within the area for which the Special Charge is declared.
4. The total cost of the performance of the function and exercise of the power by Council (in relation to activities associated with the encouragement of commerce, retail activity and employment opportunities in the area for which the Special Charge is declared) and also the total amount of the Special Charge to be levied by Council is referable to the following:
 - a) For the first 9 months of the Scheme (being for the period 1 October 2022 to 30 June 2023), a pro rata amount of \$155,280.39 (being an amount which is based on a 1.75 percent increase, pro-rata for three quarters, on the amount levied in the last year of the preceding special charge scheme) will be levied;
 - b) For the second year of the Scheme (being for the period 1 July 2023 to 30 June 2024), an amount of \$210,665.15 (being an amount which is based on a 1.75 percent increase, pro-rata for four quarters, on the amount levied in the immediate preceding year) will be levied;
 - c) For the third year of the Scheme (being for the period 1 July 2024 to 30 June 2025), an amount of \$214,351.79 (being an amount which is based on a 1.75 percent increase on the amount levied in the immediate preceding year) will be levied;
 - d) For the fourth year of the Scheme (being for the period 1 July 2025 to 30 June 2026), an amount of \$218,102.95 (and being an amount based on a 1.75 percent increase on the amount levied in the immediate preceding year) will be levied; and

- e) For the fifth year of the Scheme (being for the period 1 July 2026 to 30 June 2027), an amount of \$221,919.75 (and being an amount based on a 1.75 percent increase on the amount levied in the immediate preceding year) will be levied.

These being amounts which, in total, will raise an amount of \$1,020,320.03 over the 4 years and 9 months period of the Scheme.

- 5. The period for which the Special Charge is declared and will remain in force is a period of four years and nine months commencing on 1 October 2022 and ending on 30 June 2027.
- 6. The area for which the Special Charge is declared is all of the land referred to as the Central Coburg Shopping Precinct, as identified and shown on the plan set out in the attachment forming a part of this declaration (Attachment 1).
- 7. The land and the properties in relation to which the Special Charge is declared is all that ratable land described in the following street addresses and more particularly set out in Attachment 2 to this report:
 - a) 311-517 (inclusive) and 322-502 (inclusive) Sydney Road, Coburg;
 - b) 94-124 (inclusive) and 81B-133 (inclusive) Bell Street, Coburg;
 - c) 2-8 (inclusive) and 1-25 (inclusive) Munro Street, Coburg;
 - d) All properties in Louisa Street, Coburg;
 - e) All properties in Victoria Street, Coburg; and

The Special Charge will be declared and assessed in accordance with the amounts set out below as they are to be applied to each property in the attachment forming a part of this declaration (Attachment 2), such amounts having respectively been assessed and levied on the basis of a rate in the dollar applied to the capital improved value (CIV) of each property included in the Scheme (such values to be initially determined and as in force as at 1 April 2022 and remain unchanged until the Scheme ends); and
 - a) For the first 9 months of the Scheme (being for the period 1 October 2022 to 30 June 2023), the following amounts are specified as being payable by those properties in the following tiered benefit classifications (in order to raise a pro rata amount of \$155,280.39):

For the purposes of having determined the total amount of the Special Charge to be levied under the Scheme, Council further considers and formally determines for the purposes of sections 163(2)(a), (2A) and (2B) of the Act, that the estimated proportion of the total benefits of the Scheme to which the performance of the function and the exercise of the power relates (including all special benefits and community benefits) that will accrue as special benefits to all of the persons who are liable to pay the Special Charge is in a ratio of 1:1 (or 100%). This is on the basis that, in the opinion of Council, all of the services and activities to be provided from the expenditure of the Special Charge are marketing, promotion and advertising related and will accordingly only benefit those properties and businesses included in the Scheme that are used, or reasonably capable of being used, for retail, commercial or professional purposes.
 13. CCBA is to be authorised to administer the proceeds of the Special Charge on the express condition that CCBA enters into a funding agreement with Council for the period of the Special Charge.
 14. 7.4 41-43 SERVICE STREET, PARK CLOSE TO HOME - ENGAGEMENT OUTCOMES AND FINAL PARK CONCEPT

Executive Summary

In early 2021, Council commenced a three-stage community engagement process leading to the proposed design of the new Park Close to Home at 41-43 Service Street, Coburg. This comprised:

Stage 1: to seek community ideas for our new park over a five-week period (online engagement). This consultation used a 'Word Cloud' to prompt for responses on people's aspirations for the park. Among the 84 responses, 'green' was a dominant theme: trees, shade, lawn, native planting. Play opportunities also featured: seating, shelter, a playground that is inclusive with a variety of play opportunities including nature and water play, for all ages and abilities. A community garden and references to local histories were also requested. This initial feedback was used to inform the draft concept plan for the park.

Stage 2: to seek community feedback on a draft concept plan (online, letter box drops and two onsite sessions). This received very positive responses (41 responses overall). There were constructive suggestions for amendments to the design that would aid neighbouring properties in feeling more comfortable regarding potential overlooking or noise issues. These were built into the plan.

Stage 3: to loop back on stage 2 with the modified concept plan (email to earlier participants and Conversations Moreland invited comment). With only two further interactions, the changes were well received by the community and detailed design is now underway to form the basis of the procurement and construction process.

The proposed final concept is now presented to Council for endorsement, prior to officers proceeding to detailed design and construction of the park.

The park will be delivered within the remaining available budget of \$664,581.00. The project is planned to be completed by April 2023.

7.5 NAMING THE PARK AT 132-134 CARDINAL RD GLENROY - PROPOSED SHORTLIST

Executive Summary

A new park has been created at 132-134 Cardinal Road, Glenroy as part of Council's 'Park Close to Home' project. A locality plan is shown in Attachment 1. This report proposes a shortlist of names for the community to vote upon.

An initial public consultation seeking naming suggestions for the new park was listed on Council's website and letters were sent to surrounding properties for a period of 42 days, until 4 February 2022.

Two submissions were received, with only one suggesting a park name from this consultation process. Council officers also put forward one naming submission from a previous project. These two names; 'Citadel' to commemorate the previous site owners, the Salvation Army and 'Bagung Djerring' meaning Gather Together in Woi Wurrung language, were reported to the Council meeting held on 13 July 2022.

On 13 July 2022 Council deferred a decision on item 7.3 *Naming of Park at 132-134 Cardinal Rd Glenroy – Proposed Shortlist*, to extend the community consultation process to invite additional names, reconsider other possible names previously submitted for other naming projects, and then receive a further report in September 2022 to endorse for inclusion in a voting poll a list of names for the park.

Following this, on 1 August 2022 a second round of community consultation commenced on Council's Conversations Moreland website. Further advertising was undertaken on Facebook, Instagram, public radio, to nearby local schools and community centres.

Previously submitted names from other naming projects have also been assessed and three names selected as meeting the naming rules and Council's preference criteria for this park.

From the extended consultation, eleven new submissions were received. A list of the names suitable for this park from other naming projects and the names from both community consultation processes can be viewed in Attachment 2.

One of the names chosen from a previous naming project was also a submission received in the extended consultation process, this name is a commemorative name and family permission has been granted.

Council officers also re-consulted with the Wurundjeri Woi Wurrung Cultural Heritage Aboriginal Corporation for the proposed use of three indigenous names from previous naming projects for this park and permission has been granted.

The below five names have met the mandatory Geographic Names Victoria's (GNV) Naming rules for places in Victoria, statutory requirements for naming roads, features and localities, and Council's preference criteria in the Naming Moreland Places Policy (the Policy).

Council will consult with the community to understand their preferences via a voting poll. The names proposed to be included in the voting poll are:

- Bagung Djerring Park
- Citadel Park
- Stewart Murray Park
- Walert Park
- Yubup Park

The proposed process for carrying out the poll is in accordance with the Naming Rules. Access to the poll will be via Council's Conversations Moreland website and written responses via email or letters will also be considered.

Once voting is complete, a further report will be presented to Council with the results and a recommendation for a new name to be lodged.

7.6 CHILDREN, YOUNG PEOPLE AND FAMILIES PLAN 2021-2025 - IMPLEMENTATION OF YEAR 1 ACTIONS

Executive Summary

The Moreland Children, Young People and Families Plan 2021-2025 (the Plan) aims to improve health, wellbeing and educational outcomes for children, young people and families to enact the Plan's vision of 'a community where children, young people and families are healthy, resilient, empowered, safe and belong'.

The Plan's associated Implementation Plan 2022-2025 details the actions and activities that will be undertaken in each of the Plan's three outcome areas. The Plan takes a whole of Council approach in its implementation and seeks to engage children, young people and families in program planning and decision making. To fulfil the vision of the Plan, Council has continued to collaborate with community, partner organisations and the State Government to achieve the implementation of year 1 actions.

The annual review of the Plan highlights the volume and breadth of work undertaken despite the challenges of COVID, particularly to service delivery. The annual review has identified the achievements of the Plan in Year 1 of its implementation and are outlined in detail in **Attachment 1**.

7.7 HUMAN RIGHTS POLICY 2016-2026 (REVISED)

Executive Summary

Moreland's first Human Rights Policy was adopted in 2016 and in 2022 has been updated to reflect the changed social, political, economic, environmental and health context. This report outlines the process undertaken to revise the policy and the resulting key changes.

During 2021-22 a process to revise the policy was undertaken. This involved aligning the policy to new legislative frameworks; namely the Local Government Act 2020 and the Gender Equality Act 2020, identifying emerging trends and issues that impact on human rights and social justice, benchmarking the policy against other Local Government's approaches, consulting staff around implementation and effectiveness and engaging community members.

The policy has been further strengthened by a stronger Acknowledgement of Country and recognition of First Nations people, updated context to account for Climate Change and Climate Justice, and a recognition of the impact of COVID-19 and greater inequalities.

Inclusion of updates on priority group descriptions in line with contemporary understandings and inclusion of 'priority issues'. The policy also includes a stronger statement on Council's role in advocacy.

Beyond compliance, Moreland Council takes a proactive approach to promoting a culture of human rights, valuing diversity and inclusion both internally at Council and in the

community. Acknowledgement of Council's role in working towards social justice and in providing conditions for all people to have access to opportunities and control over their own lives is an important addition to the revised policy.

7.8 SUMMER 2022-23 SPORTS GROUND TENANCY ALLOCATIONS

Executive Summary

Council has a strong commitment in providing its community with sporting and recreational facilities and opportunities, encouraging them to stay active to improve their health and wellbeing outcomes.

Council's Allocation and Use of Sporting Facilities, Grounds and Pavilions Policy 2016 (the Policy) provides a framework for the annual and seasonal allocation of sporting grounds and pavilions to clubs through a tenancy agreement.

In line with the Policy, facilities are allocated to clubs with sound governance structures, open membership for men, women and juniors, and a demonstrated commitment to social responsibility, including participation in club development programs.

Fourteen summer seasonal tenancy applications were received from clubs and all requests can be accommodated. This report also provides an update on progress of the club's levels in junior and female participation. Several clubs are still in the process of submitting their compliance documentation which is required prior to receiving their summer 2022-23 sports ground seasonal allocation.

The Allocations Policy is currently being reviewed for Council consideration in late 2022.

Executive Summary

Council's draft hardship policy was presented to Council at its meeting on 13 July 2022, for endorsement for community consultation. Council invited community submissions between 2 August 2022 – 16 August 2022 via Conversations Moreland.

Whilst the hardship policy was on display for community consultation, the COVID hardship policy was extended until 30 September 2022. This allowed Council to continue to assist residents with short-term payment deferrals.

To address the observations made in the Victorian Ombudsman's "Review of Hardship - Local Councils" as published in May 2021 and to assist in recovery of our community following the impacts of COVID-19, Council has prepared a Hardship Policy (shown at Attachment 1), which is guided by the principles of:

- Transparency, efficiency, capacity to pay and equity by treating all debtors consistently and in a fair manner
- Customers are encouraged to utilise financial counselling, legal and other supports
- Legal action to recover debt should be the last resort.

At the close of the submission period, 4 submissions were received. A summary of the submissions received, together with Council Officer responses is provided in Attachment 2. This report does not recommend any further amendments to the draft Hardship Policy as a result of the submissions received, as summarised in the Issues section of this report and included in Attachment 2.

7.13 RFT-2022-287 - PROVISION OF AN INTEGRATED PARKING MANAGEMENT SOLUTION

Executive Summary

This report seeks the award of the preferred contractor, DCA Cities Holdings Pty Ltd (DCA Cities), for contract RFT-2022-287 Provision of an Integrated Parking Management Solution.

Presently there are two separate contracts for the management of Council’s parking related services: firstly, contract 649T covering parking sensors, infringement issuing software, online parking permits (ePermits) and viewing parking infringements online; and secondly, contract 537ST covering parking ticket machines and ticketless mobile phone application payments.

Council undertook a tender process to combine all parking management services under one contract eliminating the need for two parking applications and bringing together the benefit of having an all-in-one integrated parking management solution.

The tender for the new contract was released on 30 April 2022 and closed on 30 May 2022. Six responses were received and assessed, with three short listed and interviewed by the assessment panel. An addendum and comprehensive pricing schedule template was then sent to the respondents to clarify and assist with the evaluation of tender prices. The preferred supplier is DCA Cities.

The tender complies with section 109(1) of the *Local Government Act 2020*.

The relevant Director was given delegation to approve up to 20 per cent annual operating costs for unforeseen maintenance and support expenses on top of the contracted amount each year for contract 649T under a previous Council resolution (ref Council Resolution DCF84/19 from the 13 November 2019 Council meeting). This amounted to approximately \$100,000 per year. These expenses can include relocation/replacement of parking sensors and associated infrastructure as well as replacing ticket machine rolls etc. It is not expected that the 20 per cent contingency will be required for this new contract, but rather officers are seeking a \$50,000 per annum (not indexed for inflation) contingency allowance for unforeseen maintenance expenses under this new contract.

Although this tender allows for five 2-year contract extension options, these costs were not requested from the tenderers and as such Council approval will be requested prior to contract extension options being exercised.
