1.0 Introduction

This report presents the findings from the 2018 Community Indicators Survey conducted by Wallis Market and Social Research on behalf of the City of Moreland.

1.1 Background and Objectives

This is a key piece of research that fits in with Council objectives to gain insight about how the community feels about local government services and policies. A Community Indicators survey has been conducted since 2005 and was originally developed around the Moreland Municipal Public Health Plan. It was also designed to identify and analyse social issues. Over the years there have been updates and changes to the questions as necessary, to align with current information aims and Council strategy.

The broad aims of the Community Indicators Survey are to:

- Measure community perception and well-being and identify changes over time;
- Identify emerging needs and issues to assist Council's advocacy role; and
- Collect demographic information for purposes of analysis.

1.2 Methodology

Sampling and data collection

A sample of landline and mobile numbers, matched to the City of Moreland area by postcode, was drawn at random from an accredited supplier of publicly available phone records that is used exclusively for market and social research. In order to ensure representation of younger and mobile-only households, 30% of the sample consisted of postcode-matched mobile phone sample.

Sample was drawn using postcode matching for the following suburbs:

- Brunswick
- Brunswick East
- Brunswick West
- Coburg
- Coburg North
- Fawkner
- Glenroy
- Gowanbrae
- Hadfield
- Oak Park
- Pascoe Vale
- Pascoe Vale South

Small sections of Fitzroy North and Tullamarine are also a part of the Moreland municipality. To ensure that residents in these areas were given the opportunity to participate in the survey, individuals from households in these areas were also included in the sample and screened to determine whether they reside within the Moreland municipality. Responses from Fitzroy North residents have been included with responses from the nearest suburb, Brunswick East. Tullamarine residents have been included with Gowanbrae.



The survey was conducted by Computer Assisted Telephone Interviewing (CATI) among residents of the City of Moreland aged 18 years and over. A total of n=650 telephone interviews were conducted during 9-27 November 2018. A team of 19 Wallis interviewers were briefed in person by the project team, ahead of commencing fieldwork.

Minimum quotas of gender, age and suburb were applied during the fieldwork phase, and quotas were closely monitored to ensure good representation of the Moreland Community. The final survey sample was then weighted to match the demographic profile of the City of Moreland as determined by the most recent ABS population estimates.

The table below shows the unweighted and weighted distribution of the final sample.

The questionnaire

The Community Indicators Survey questionnaire from 2016 was reviewed by Moreland City Council to update and align the measures to current Council priorities. Some questions were followed up with open-ended questions to gather qualitative feedback where respondents disagreed with key statements.

The 2018 questionnaire took 13.1 minutes on average to administer. A copy of the questionnaire is attached at Appendix A.



1.3 Guide to this report

How scores are calculated

The Community Indicators Survey asks respondents to state the extent to which they agree or disagree with a range of statements that relate to the areas of priority identified by Council. The scores for each priority area are based on the percentage of respondents who agreed with each statement; the "% Agree" score for a particular statement is the combined proportion of respondents who said they 'strongly agree' or 'slightly agree' with that statement. In calculating the scores, 'Don't know' responses are removed from the base.

Statements measured in the survey were grouped into the following key themes:

- Access to services
- Housing and the built environment
- Public parks and recreational facilities
- Employment and education opportunities
- Community and diversity
- Personal wellbeing and safety
- Environmental issues and sustainability
- Participation and engagement

Average scores for each key theme are calculated by taking an average of the % Agree scores for statements that related to each indicator contained within the theme.

Rounding

Percentages are generally rounded to whole numbers. Some totals may not add to 100 percent due to rounding.


Verbatim responses

Verbatim responses to the open-ended questions asked of all respondents have been reviewed and responses have been coded into themes.


3.0 Detailed findings

3.1 Key themes: Strengths and weaknesses in 2018

The average agreement score across all themes in 2018 was 78%. The City of Moreland's key strength in 2018 was community and diversity, with an average agreement score of 91%. Other areas that received high average agreement scores were environmental issues and sustainability (88%), and personal wellbeing and safety (87%).

Housing and the built environment had the lowest average agreement score of 66%.




3.2 Access to Services

Time series comparisons

Most access to services indicators had slightly lower percentages of respondents agreeing in 2018 compared with 2016. Statistical testing did not reveal any statistically significant differences in the results over time, but the time series charts indicate a general pattern of slightly lower scores on most measures within this theme. This was most notable with the families having access to childcare indicator dropping from 74% in 2016 to 63% in 2018; and agreement dropping from 65% in 2016 to 54% in 2018 for people with disabilities having good access to public transport. Agreement with the elderly having adequate access to aged care services also declined, from 72% in 2016 to 62% in 2018. Agreement with the affordability of medical services required by the respondent and their family remained stable at 85%. While 90% of respondents in 2016 agreed that their local community has good health and community services, 86% agreed in 2018. Overall, agreement with access to services statements was lower in 2018 (70%) compared to 2016 (77%).

Figure 3 Access to services: Time series






Detailed results for 2018

Within the access to services theme, the indicators with the strongest agreement from City of Moreland residents were access to health and community services (86%), and affordability of medical services (85%).

Only 54% of respondents agreed that people with disabilities have good access to public transport. This contrasts with 89% of respondents agreeing that they had good access to public transport in the theme of housing and the built environment. There were no statistically significant differences in rates of agreement between suburbs.

Rates of agreement were similar between adequate access to child care (63%), and adequate access to aged care services (62%). Although, respondents were more likely to disagree that there was adequate access to aged care services (27%), than disagree that there was adequate access to child care (23%).

Figure 4 Access to services: 2018






3.3 Housing and the built environment

Time series comparisons

Agreement with good access to public transport in the City of Moreland is relatively stable in 2018 at 89% (from 90% in 2016). There was a marginal increase in agreement that respondents' local shopping areas provided for their basic needs, from 88% in 2016 to 91% in 2018.

The housing and the built environment theme continues to show weaker performance in 2018, with less than 50% of respondents agreeing that the sort of housing being built is neighbourhood appropriate (45%, down from 49% in 2016), and only 36% of respondents agreeing that housing was affordable (down from 45% in 2016). Other measures within this theme were relatively stable.

Figure 5 Housing and the built environment: Time series






Detailed results for 2018

Housing and the built environment received the lowest average agreement score in 2018. Specifically, housing affordability was the lowest performing indicator within this theme, with 60% of respondents disagreeing that housing was affordable. Just over half of respondents disagreed that the sort of housing being built is appropriate for their neighbourhood (52%). 89% of Gowanbrae (including Tullamarine) residents agreed that the sort of housing being built is appropriate for their neighbourhood, this percentage was higher, and statistically significant in comparison to the overall sample.

Local shopping areas meeting basic needs had the highest agreement for this theme at 91%, closely followed by access to public transport (89%). As noted in the access to services theme, perceptions of accessibility to transport was dramatically reduced when the question was disability specific. Gowanbrae (including Tullamarine) residents were least likely to agree that there is good access to public transport. Their agreement rate of 53% was considerably lower than other suburbs in Moreland, and when compared to the overall sample was statistically significant.

A high proportion of respondents (71%) agreed that there is adequate provision for cyclists in their area, however, a quarter of respondents disagreed.

Figure 6 Housing and the built environment: 2018






3.4 Public parks and recreational facilities


Time series comparisons

The average agreement score for the public parks and recreational facilities theme was relatively stable in 2018 at 81% (82% in 2016). No significant changes were found for the agreement scores of the four indicators within this theme. The agreement score for good parks and open areas was stable at 88% (89% in 2016), and the agreement score for maintenance of local parks and open areas was also relatively stable at 86% (84% in 2016). The agreement score for access to recreation facilities remains high at 86% (85% in 2016).


Agreement with there being plenty for young people to do in the area is relatively low; 65% agreed with this in 2018, compared to 68% in 2016.


Figure 7 Public parks and recreational facilities: Time series












Detailed results for 2018

Overall, the public parks and recreational facilities theme performed well in 2018 with three of the four indicators receiving agreement scores of 86% or higher. City of Moreland residents were likely to agree that the municipality has good parks and open areas, and that they are well maintained. They also agreed that the municipality has a variety of recreation facilities and leisure activities on offer.

Only 65% of respondents agreed that there was plenty for young people to do in the area. A significantly higher proportion of residents in Brunswick agreed with this indicator (82%).

Figure 8 Public parks and recreational facilities: 2018






3.5 Employment and education opportunities

Time series comparisons

Overall, agreement with the employment and education opportunities theme was stable in 2018 at 68% (66% in 2016). However, this was the second lowest performing theme for the municipality in 2018. Perceptions of a strong local economy appear to have improved, with 71% of those surveyed agreeing compared with 62% in 2016. Additionally, more respondents agreed that Moreland has good employment opportunities in 2018 (53%) compared to 2016 (48%).

Respondents were more likely to agree that there are opportunities for learning and development for people of all ages in 2018 (74%) than in 2016 (70%). Conversely, perceptions of both good quality primary schools and specifically, good quality government secondary schools declined in 2018. While 88% of respondents in 2016 agreed that Moreland has good quality primary schools, only 85% agreed in 2018. Similarly, where 62% of respondents in 2016 agreed that their area had good quality government secondary schools, only 59% agreed in 2018.

Detailed results for 2018

While agreement with good quality primary schools had declined slightly from 2016 to 2018, this was the strongest performing indicator within the employment and education opportunities theme. 85% of respondents agreed that the area has good quality primary schools. Residents of Pascoe Vale were most likely to agree with this indicator (98%). Residents of Gowanbrae (including Tullamarine) were least likely to agree with this indicator (28%).

Perceptions of access to good quality government secondary schools were much weaker than primary schools, with only 59% of respondents agreeing.

Gowanbrae (including Tullamarine) residents were also least likely to agree that there are opportunities for learning and development for all ages, with only 20% agreeing in 2018.

53% of respondents agreed that good employment opportunities were available in the City of Moreland. This was the weakest performing indicator within the employment and education opportunities theme. This is explored further in **Table 4** below.

Figure 10 Employment and education opportunities: 2018



211 respondents disagreed that there are good employment opportunities in the municipality. The most common reason for disagreement was having to travel outside of the City of Moreland for work, with respondents stating that jobs are located in the city or elsewhere (35%). The second most common reason for disagreement were that there was no work in the respondent's field, or that only retail or hospitality roles were available in the area (18%). 12% of respondents mentioned businesses or industries closing down in Moreland as their reason for negative ratings of employment opportunities.

Some examples of verbatim comments relating to the key themes identified are as follows:

- The relative range of business is good, but there is more potential for growth.
- We have lost a lot of industry and employment over the last few years.
- Most people I know in this area commute to the city for work because there are not many employment opportunities around...
- **11** ...I just don't see much employment in Moreland, it is more in the city and surrounding areas.
- I don't think that we have the manufacturing industry that we used to have in the area.
- I feel like most people need to go to the city for work.
- ...I think that most people who live in Moreland have to travel outside of Moreland for their own work, there is not enough industry to support people around their own home.
- I think that there's not many local businesses outside retail and catering. I think that there's not a diversity of business types...
- There's a lot of factories that have closed.





3.6 Community and diversity


Time series comparisons


Community and diversity was the highest performing theme for the City of Moreland in 2018. Of the seven indicators, six had higher agreement percentages in 2018 than 2016.


Figure 11 Community and diversity: Time series






















The biggest increase was the getting to know your neighbours indicator, up from 87% in 2016 to 94% agreement with those surveyed in 2018. People from different ethnic backgrounds are made welcome in your neighbourhood was the third highest performing indicator overall in 2018, with 95% of respondents agreeing, up from 90% in 2016. 94% of respondents agreed that cultural diversity enriches local community life, increasing from 92% in 2016. Most respondents agreed that their area is a good place to live, up from 93% to 96% in 2018. The good place to raise a family (94%) and feeling part of your community (89%) indicators both had slight increases in 2018 up from 90% and 84% respectively. The only indicator in this theme to decline from 2016 was people with a disability are included in community life, down from 83% to 73% in 2018.

Detailed results for 2018

Perceptions of community and diversity was the City of Moreland's biggest strength in 2018. 96% of respondents agreed that their area is a good place to live, with only 3% of respondents disagreeing. Residents of Brunswick West were most likely to agree (97%). The lowest performing indicator in this theme was the perception that people with a disability are included; around one in five (19%) of those surveyed disagreed with the statement.

People living in the City of Moreland value cultural diversity, with 95% agreeing that it is welcome in their area, and 94% agreeing that it enriches local community life. Residents of Hadfield were least likely to agree that people from different ethnic backgrounds are made welcome in their neighbourhood (78%), which was statistically significant compared to the overall sample.

72 respondents (9%) disagreed that they felt part of their community, and were probed to ascertain why they felt that way. Their verbatim responses were recorded and reasons for negative ratings are available in **Table 5**. Brunswick residents were most likely to agree that they felt part of their community (99%).




Figure 12 Community and diversity: 2018

As shown in **Table 5** on the following page, the most common reason for disagreeing that they felt part of their community, was that the respondent identified as keeping to them self, or had a perception of others in the community as keeping to themselves. Other respondents identified a lack of spaces or facilities as their reason for not feeling a part of their community (17%). Conflicting with the positive attitudes evident in the high levels of agreement with the cultural diversity indicators, "No sense of community" and "Lack of social cohesion/too much cultural diversity" were also dominant reasons for not feeling a part of community (15% each).

Some examples of verbatim comments relating to the key themes identified are as follows:

- I keep to myself to be quite honest, don't have anything in common with people around here.
- A lot of people tend to keep to themselves.
- I haven't been able to find an appropriate way of linking to peers that is suitable for me.
- I haven't made much of an effort. I'm involved with the local footy club. I'm a bit time poor, but could make more of an effort.
- ...we all keep to ourselves, there's not a lot of communication.
- I don't normally get involved in community things.
- I don't participate in any community activities.
- I haven't had much contact with people.
- I don't really do anything to become part of the community.
- I don't actively get involved in too many things.
- There are not as many people of my age group and my background. People of my age and background don't live here anymore.
- I don't get out much. I am very elderly. I don't get out a lot in the community.
- I don't want to get involved.
- I don't have much contact with the community.
- At my age I don't do anything and I don't know anybody.
- It's not a community, you just live there...




3.7 Personal wellbeing and safety

Time series comparisons

Overall, the personal wellbeing and safety agreement score is stable at 87% in 2018. All of the indicators in the personal wellbeing and safety theme were relatively stable, apart from a slight (not statistically significant) increase in the agreement score for having enough money to meet needs, up from 82% in 2016 to 87% in 2018.

There was a slight change of wording to one indicator in 2018; previously, respondents were asked to state their agreement with the statement "You can get help from family, friends **and** neighbours when you need it". This was slightly edited to "family, friends **or** neighbours" in 2018; 94% of respondents agreed with the statement in 2018, compared to 91% in 2016. This difference was not statistically significant.

Figure 13 Personal wellbeing and safety: Time series






Detailed results for 2018

Three of the personal wellbeing and safety indicators were top overall indicators for Moreland in 2018. Over 90% of respondents agreed that their area is a safe place to live during the day, that they were coping with stress in their family or home life, and that their family, friends or neighbours will help them. 87% of respondents agreed that they had enough money to meet their needs.

The Moreland residents surveyed were less likely to agree that their area is a safe place to live at night compared to during the day; almost one in four (24%) of respondents disagreed their area is a safe place to live at night, whilst only 6% disagreed that their area is a safe place to live during the day. Residents of Oak Park were most likely to agree that their area is a safe place to live at night (96%), which was statistically significant compared to the overall sample.

Residents of Glenroy were more likely to strongly disagree that they can cope with the amount of stress in their family or home life (9%).

3.8 Environmental issues and sustainability

Time series comparisons


Due to substantial changes to the set of indicators relating to environmental issues and sustainability in 2018, it is not possible to draw a time series comparison for this theme.

Detailed results for 2018

New questions were included in the environmental issues and sustainability theme asking respondents about their level of agreement with the importance of using environmentally friendly forms of transport, the importance of reducing the amount of waste they put in the garbage bin, whether they felt it is important that they take actions to reduce emissions, and whether Council is helping the municipality become a green and environmentally friendly city.

City of Moreland residents were highly likely to agree with both the environmentally friendly transport and waste reduction indicators, with 96% of respondents feeling it is important to reduce the amount of waste they put in the garbage bin, and 93% of respondents agreeing that they feel it is important to use environmentally friendly forms of transport as much as possible.

Of the 650 people surveyed, 644 Moreland residents indicated which method of transport they use to travel to work. 87% of those who use a car to travel to work feel that it is important that they use environmentally friendly forms of transport as much as possible, compared to 100% of those who use public transport, cycle or other method of transport to get to work.

92% of those surveyed agreed that they feel it is important that they take actions to reduce emissions to prevent climate change. 62 respondents (7%) disagreed that they feel that it is important that they take actions to reduce emissions to prevent climate change, and were probed for details of why they felt that way. Their verbatim responses were recorded and reasons for negative ratings are available in **Table 7** on the following page. The most common reason for this response (27%), was that the respondent didn't believe in climate change, was a sceptic or climate apathetic. Other respondents



indicated that Council needs to do more (20%). 18% of negative responses were attributed to respondents feeling that their actions to reduce emissions would have no effect, or no significant effect.

Respondents were asked "Would you agree or disagree that you feel it is important that you take actions to reduce emissions to prevent climate change?"

Some examples of verbatim comments relating to the key themes identified are as follows:

- I don't believe in the science.
- It's greatly overrated. This emissions thing. What we do makes no difference to the environment whatsoever. We are worrying about things when 99.9% of the pollution comes from China. India or the USA.
- I'm not sure if it is something I can make a difference [to] by myself.
- ...if you get carried away it will cost us our jobs.
- I don't really believe in climate change.
- ...there is not much being done about it at this stage, that I am seeing around here anyway. It is over congested and over populated.
- There is nothing that I do or am involved with that alters the environment.
- I'm not 100% convinced that everything being done is appropriate. There's a lot of money involved in this cause, and everyone wants cleaner air, cleaner water. Sometimes, what people want to do involves pain for other people, like lower income people. The people who get solar panels are subsidised by the taxpayer, and it's generally not lower income earners.
- I don't think there has been enough promotional material provided by local government.
- ...the information is not out there. I'm not sure what the council can do about it.
- The community doesn't take action, there's still open fireplaces, throwing rubbish on the ground, too many cars on the road.



34 respondents (7%) disagreed that they feel it is important that they reduce the amount of waste they put in the garbage bin and were probed to describe why they felt that way. Their verbatim responses were recorded and explanations for negative ratings are available in **Table 8**. Over half of residents who disagreed qualified this by stating that "the waste needs to go somewhere" or that they can't reduce their waste. Other respondents (16%) endorsed better recycling programs or information. 10% of residents who gave negative responses asserted that they pay for waste collection. Residents of Gowanbrae (including Tullamarine) were least likely to agree that they feel it is important that they reduce the amount of waste they put in the garbage bin (69%), which was statistically significant compared to the overall sample.

Some examples of verbatim comments relating to the key themes identified are as follows:

- I feel some residents are already cognisant of the impact it has on the environment and have already reduced their waste quota.
- I have nowhere else to put it.
- ...whatever rubbish you've got, you have to put it somewhere, you don't want it thrown in the street.
- ...the house sizes vary but the bin sizes don't.
- ...the community needs to be educated on what kind of garbage goes into what bin and what things can be further recycled instead of going to landfills.
- ...sometimes you can't help it, when you have kids there is only so much you can do, can only reduce so much.
- ...I can't reduce the garbage any more.


In contrast with the strong performance on indicators of personal responsibility in this theme, a lower proportion (71%) agreed that Council is helping the municipality to become a green and environmentally sustainable city.






Figure 16 Participation and engagement: Time series




People have opportunities to participate in the decisions made by their local government




You feel adequately informed about Council services







The average agreement score for indicators in the participation and engagement theme was relatively stable at 70% in 2018 (69% in 2016).


The indicator with the most improved agreement percentage from 2016 was all people in Moreland are treated equally, rising from 63% to 74% in 2018. Perceptions of all people in Moreland being treated with respect and dignity also improved from 73% in 2016 to 81% in 2018. There was also a slight increase in agreement with all people in Moreland are treated fairly from 72% in 2016 to 78% in 2018.

These positive increases were not reflected in the overall agreement score for the theme due to decreases in the remaining three indicators. The biggest decline in agreement for this theme was with the people have opportunities to participate in the decisions made by their local government indicator, which fell from 66% in 2016 to 57% in 2018. City of Moreland residents were also less likely to agree that there are opportunities for them to have a say about issues that are important to them in 2018 (67% compared to 74% in 2016). They were also less likely to agree that they feel adequately informed about council services in 2018 (61% compared to 64% in 2016).

Detailed results for 2018

The top performing indicators in this theme relate to the perception that all people in Moreland are treated equally, fairly, and with respect and dignity. However, the results suggest that Moreland residents are less positive about feeling that they are given opportunities to have their say, and are adequately informed about council services. The lowest performing indicator in this theme shows only 57% agreeing that they can participate in Council decisions.
